

VACANCY CIRCULAR

Subject:- Filling up the vacancy of Assistant Commissioner in the office of Competent Authority, Chennai on deputation basis – regarding.

It is proposed to fill up a vacancy of Assistant Commissioner (Group 'A' Rs.8000-13500) in the office of Competent Authority (Smugglers and Foreign Exchange Manipulators (Forfeiture of Property) Act, 1976 and Narcotic Drugs and Psychotropic Substances Act, 1985), at Chennai, under Department of Revenue (HQ Division) on deputation basis.

The following officers may apply for the post :-

Officers of the All India Services, Indian Customs and Central Excise Service, Indian Revenue Service (Income Tax), Central Bureau of Investigation, Officers under the Central Board of Direct Taxes and the Central Board of Excise and Customs, Central Bureau of Narcotics and the Directorate of Enforcement (Ministry of Finance),

- (a) (i) holding analogous posts on a regular basis or
(ii) with 3 year's regular service in posts in the scale of pay of 6500-10500 or equivalent; and
- (b) having/possessing 2 years' training/experience in enforcement of regulatory laws/investigation of offences and collection of intelligence thereof. Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some organisation/department of the Central Govt. shall ordinarily not exceed 3 years. The maximum age limit for appointment by deputation be not exceeding 58 years as on the closing date of receipt of application.
